#### Subject: August/September 2016 Dredging Activities and Special Projects Report

The Dredging Program Manager's activities for the August to mid-September 2016 period are reviewed below:

#### FY2017 Federal Dredging Appropriations

The U.S. Congress returned to work the week following Labor Day after their summer recess. Since it is now apparent that none of the FY2017 appropriations bills will have been finalized by the commencement of the new fiscal year on October 1, 2016, a Continuing Resolution (CR) must be passed by September 30 to avoid a government shutdown. It appears likely that a CR providing funding into December is likely. The final FY17 appropriation levels could then be resolved by the lame duck session of Congress that will convene after the November elections. From the Port District's perspective this timing is preferable to a CR that would extend until March 2017 that is being pushed by some of the conservative members of Congress.

It is still expected that the CR will include \$4.3 million for the dredging of Ventura Harbor which under the terms of Manson's existing contract with the Corps of Engineers will achieve a dredging volume of about 400,000 cu.yds. of material. I believe that at least an additional \$1.5 million will be required in order to achieve a total volume of 640,000 cu.yds. In recent years the Port District has been able to secure additional dredging funds via a "Work Plan" process that the Corps of Engineers develops after the Congress provides the Corps with the final appropriations levels. At this point, however, all we can do is wait for the CR process to play out.

#### FY2018 Federal Dredging Appropriations

While, as noted above, the FY2017 Congressional appropriations process is yet to be resolved, the Administration is currently preparing its proposed FY2018 Budget. We have therefore been working with Congresswoman Brownley's office to have the harbor's FY2018 funding requirements communicated to the Administration. Enclosed are two letters that the Congresswoman graciously forwarded to OMB and the Assistant Secretary of the Army for Civil Works requesting that \$6 million be included in the Administration's FY2018 budget.

#### Harbor Maintenance Dredging Permits

On September 8, 2016, the California Coastal Commission (CCC) approved a new 10 year maintenance dredging permit for the harbor. The permit includes all channels in the inner harbor as well as the federal entrance channel and sand traps.

On October 13, 2016, the Los Angeles Regional Water Quality Control Board has scheduled to consider an order establishing the discharge requirements for the Port Districts maintenance dredging program for the next 5 years.

#### Harbor Village Phase II ADA Improvements

While J&T Engineering and Construction has completed all of the ADA concrete work at Harbor Village, they have failed to install the stainless steel railings called for in their contract. They continue to insist that the railings will be installed any day now but the contract called for all work to be completed by September 3, 2016. As a consequence, J&T has been advised that liquidated damages are now accruing at the rate of \$500 per day (see attached notice of 9/14/16).

#### Roof Rehabilitation Work (Phase II)

Rasmussen and Associates expects to finalize the plans for the roof rehabilitation work at 1431, 1591, and 1691 Spinnaker Drive and have them submitted to the City for plan check review by the end of September.

#### **Harbor Village Phase III ADA Improvements**

RRM's construction plans for the phase III ADA improvements are presently undergoing their 2<sup>nd</sup> plan check review at the City Building Department. We hope to be able to seek competitive bids by early October.

#### Harborwide ADA Improvement

Jensen Design and Survey has now submitted construction plans to the City Building Department for ADA improvements at Harbor Cove, Surfers Knoll, VPD portion of the VIM parking lot, the launch ramp restroom area, and the VPD office.

#### Dear Assistant Secretary Darcy:

As you work to develop the FY2018 budget request for the U.S. Army Corps of Engineers, I write to express my strong support for continued funding for the Ventura Harbor Port District. The Ventura Harbor plays an important role in my district and I am requesting that \$6 million be included in the Administration's budget.

You may recall from my previous correspondence that the Ventura Harbor is the homeport for the U.S. National Park Service, providing access to the Channel Islands National Park System. The park's mainland visitor center receives 300,000 visitors annually with 30,000 visitors traveling to the islands and another 60,000 use park waters. Ventura Harbor also services the largest squid fishing fleet on the West Coast with revenues of \$50 million. Its commercial and recreational fishing directly employ 600 crew members, truck drivers, and laborers with an additional 300 employees in nearby processing facilities. A recent economic study indicated that Ventura Harbor has a total economic impact of \$246 million.

Over the years, funding for dredging at Ventura Harbor has been inadequate and I appreciate the U.S. Army Corps of Engineers efforts to resolve these funding shortfalls. Specifically, the additional funding provided in the FY2016 work plan came at a critical juncture for the Harbor. Faced with an unprecedented level of shoaling on account of the 2016 El Nino, the US Coast Guard was forced to close the Harbor entrance. This had a devastating impact on the communities and industries that rely on the Harbor. Thankfully FY16 work plan funds were provided to address the situation and I remain appreciative of the Corps' well timed assistance. As you develop the FY2018 budget request, I urge U.S. Army Corps of Engineers to provide the requested \$6 million to dredge of Ventura Harbor.

#### Dear Director Donovan:

As you work to develop the FY2018 budget request for the U.S. Army Corps of Engineers, I write to express my strong support for continued funding for the Ventura Harbor Port District. The Ventura Harbor plays an important role in my district and I am requesting that \$6 million be included in the Administration's budget.

You may recall from my previous correspondence that the Ventura Harbor is the homeport for the U.S. National Park Service, providing access to the Channel Islands National Park System. The park's mainland visitor center receives 300,000 visitors annually with 30,000 visitors traveling to the islands and another 60,000 use park waters. Ventura Harbor also services the largest squid fishing fleet on the West Coast with revenues of \$50 million. Its commercial and recreational fishing directly employ 600 crew members, truck drivers, and laborers with an additional 300 employees in nearby processing facilities. A recent economic study indicated that Ventura Harbor has a total economic impact of \$246 million.

Over the years, funding for dredging at Ventura Harbor has been inadequate and I appreciate the Administration's efforts to resolve these funding shortfalls. Specifically, the additional funding provided in the FY2016 work plan came at a critical juncture for the Harbor. Faced with an unprecedented level of shoaling on account of the 2016 El Nino, the US Coast Guard was forced to close the Harbor entrance. This had a devastating impact on the communities and industries that rely on the Harbor. Thankfully FY16 work plan funds were provided to address the situation and I remain appreciative of the Administration's well timed assistance. As you develop the FY2018 budget request, I urge OMB to provide the requested \$6 million to dredge of Ventura Harbor.

Pursuant to Special Condition SC-1 of the Agreement dated April 18, 2016 between the Ventura Port District and J&T Engineering and Construction, all work on the subject project was to have been completed by September 3, 2016. I spoke with your brother, Michael, during the week of September 6, 2016, and advised him of this fact.

Pursuant to Special Condition SC-2 of the aforementioned agreement, I must bring to your attention that liquidated damages are now occurring at the rate of \$500.00 for each calendar day's delay until the work is satisfactorily completed. Furthermore, your failure to install the stainless steel railings specified in the contract has created a hazardous condition, the consequences of which is a potential liability hazard for which you will be held responsible.

I urge you to remedy this situation as soon as possible.

#### **August 2016 Federal Legislative Update**

#### Fiscal Year 2018 Budget Preparations

While Congress has yet to finalize the FY17 appropriations bills, work is well underway within the Administration to prepare for the Administration's proposed FY18 budget. The budget, typically released in early February, will likely be delayed to account for a transition to a new President. However, this has not impacted the internal agency actions to formulate the annual proposal.

Within the US Army Corps of Engineers specifically the FY18 budget is beginning to take shape. Over the course of the past few months Corps Headquarters has been compiling and reviewing FY18 project needs from districts and divisions around the country. Those requests were compiled and sent to the Office of the Assistant Secretary of the Army (ASA) for Civil Works. From now through the fall Corps HQ will continue budget negotiations with the ASA's Office as well as the Office of Management and Budget (OMB). OMB is expected to make final FY18 budget decisions around Thanksgiving.

An Administration Budget for the Corps is just a starting point; it's up to Congress to provide a final level of funding through the appropriations process. Regardless of who is in the White House it is not unusual to see a low level of funding proposed by the Administration and then those cuts reversed by Congress.

#### Water Resource Bill Fails to Advance Before Recess, But Hope Remains

Despite calls from a broad coalition of stakeholders for a vote in the House and Senate on Water Resourced Development Act (WRDA) authorization bill – which have cleared committee in both chambers – Congress left town without such a vote. After focusing much of the year on unrelated aviation legislation, House Transportation & Infrastructure Committee Chairman Bill Shuster (R-PA) appears content to let the Senate take the lead.

Senate Majority Leader Mitch McConnell has pledged to bring the Senate version of the bill before the full chamber in September, but only if other pending business is addressed. Senate Environment & Public Works Chairman Jim Inhofe (R-OK) is working with Committee Ranking Member Barbara Boxer to clear the way for quick Senate consideration. EPW released its committee report (S. Rpt. 114–283) to

accompany S. 2848. Committee staff has met informally with their House counterparts to discuss their bills and Members have engaged other stakeholders and their colleagues to smooth out issues. Hope remains high that a final bill might reach President Obama before Election Day although a lame duck resolution is more likely.

The EPW-approved bill authorizes nearly \$5 billion in funding for EPA-administered water programs in addition to WRDA bill's usual authorization for Corps of Engineers projects and programs. The pending House bill does not contain any funding for the EPA because of jurisdictional differences between committees in the House and Senate.

#### **Congressional Schedule**

Note Congress is in recess and will return to Washington, DC the week of September  $5^{th}$ .



#### Federal Outlook & Update - September 2016

After a seven-week break, both the House and Senate have returned to Washington, DC. A few issues are dominating the September schedule. Foremost on the list is passing a Continuing Resolution (CR) to keep the federal government open after the start of the new fiscal year on October 1. Members will likely pass a CR providing funding into December, but there is a push by members of the House Freedom Caucus to pass a longer CR, perhaps through March 2017. Negotiations regarding the CR are ongoing and early indications point to the FY16 funding levels as the base line for an FY17 CR. Maintaining the FY16 level of funding during a CR is a key issue for the US Army Corps of Engineers and the programs and projects supported by it. It is possible that the Senate could vote on a CR as early as September 15<sup>th</sup> and then head home early to campaign forcing the House to adopt the Senate approach. Should the Senate fail in passing a CR this week they will try again the week of September 19<sup>th</sup>.

Other issues on the list for consideration include \$1.1 billion to respond to the Zika virus, and how to pay for it; and a major water resource bill (see below). Funding for Zika as well as emergency funding for the summer flooding in Louisiana could get tacked onto a CR. The House may also vote to impeach IRS Commissioner John Koskinen. Conservatives in the House have been demanding the vote to address their charges of misconduct by Koskinen.

#### Senate Expected to Take Up WRDA Bill

The Senate is ready to take up the Water Resources Development Act of 2016 on the Senate floor. The Senate bill includes significant new funding for drinking and waste water systems, in addition to WRDA's normal authorization of Corps of Engineers' navigation and flood projects.

House and Senate committee staff met throughout August to smooth over differences between the bills passed by committee in each chamber. The greatest difference between the two is that the House bill does not contain additional funding for the EPA to address lead contamination and other water quality challenges. While much of this funding is intended to address Flint, Michigan, some of the funding would be available elsewhere.

Senate Minority Leader Harry Reid (D-NV), who is retiring from Congress at the end of the year, raised the possibility that Democrats might block WRDA's passage unless they get a deal from Republicans to consider unrelated legislation, including the nomination of Merrick Garland to the Supreme Court. However, Reid did not act on his threat.

The House is also finalizing preparations to move a WRDA bill and if House leadership agrees, we could see a House bill brought to the floor under the suspension calendar the week of September 19th. If the House is successful, this would pave the way for both House and Senate staff to conference the WRDA bills during the month of October and have a final conference report ready for final consideration during the post-election lame duck session.

#### **Clinton, Trump Transition Teams Taking Shape**

Whereas presidential candidates once shunned public discussion of transition planning for fear of "measuring the drapes" before Election Day, the need for the President-elect to have a functioning Administration ready to go at noon on January 20 has necessitated formal transition operations by each major party nominee (and third party candidates if they meet a 15 percent threshold in major polls). The job of these committees is to establish departmental policy positions and begin vetting candidates for more than 1500 political appointments, including Cabinet secretaries, which need to be filled in a new Administration.

Hillary Clinton named former White House Chief of Staff and Center for American Progress founder John Podesta as her transition chairman. Former Senator and Secretary of the Interior Ken Salazar and former Michigan Governor Jennifer Granholm will lead the team. Salazar is well versed in California and Colorado River water issues, although it is not yet clear how this may translate into transition policy or appointments. Granholm is also widely believed to be the front-runner for Energy Secretary if Clinton wins. Joining them will be Center for American Progress President Neera Tanden, former Obama national security adviser Tom Donilon and Maggie Williams, a long-term aide to Hillary Clinton.

Donald Trump announced that New Jersey Governor Chris Christie would chair his transition committee. While several individuals have been mentioned for roles in his transition, no formal announcements have yet been made.

#### Clinton, Trump Call for More Infrastructure Spending

Each nominee has promised to push for significant new spending on infrastructure, including water systems, if elected. Hillary Clinton has pledged to spend \$225 billion over five years on infrastructure that includes transportation, water, energy, and high-speed broadband access. She would also spend \$25 billion to capitalize a new national infrastructure bank to attract private funding to invest in a broad range of infrastructure.

Clinton has offered that this new spending would be paid for through "business tax reform." However, she has not offered additional details on the questions that have bedeviled earlier infrastructure bank proposals, such as where it would be housed, its governance structure, project evaluation criteria, and financial controls.

Donald Trump has also called for more spending, saying that he would seek \$500 billion. He has not offered details on where this funding would come from or on the types of

infrastructure he favors supporting. He has discussed selling special bonds that might support some or all of this funding, but again, details are not available.

#### I. Maintenance

Staff is continuing to paint several areas throughout the Harbor:

a. Harbor Patrol's Docks have been refurbished with new marine grade primer and paint.

b. All four of the Monument signs located at the entrances of the Ventura Harbor Village parking lots have been re-furbished with new primer and paint.



c. I'm glad to report that the Entrance monument walls project under our Capital improvement projects is going well and we are currently 90% complete, Contractor has ordered and is waiting for the custom built stainless steel brackets that are going to be replaced that fastened the tower caps. We anticipate they will be in by next week; below are photos on

our progress.



#### II. Landscaping:

Staff is continuing on upgrading and installing drip lines for water conservation in several places where the planters are and throughout the Ventura Harbor Village landscaping areas.







#### III. Marina

Staff continues to perform the monthly inspections on all gangways, docks, and fire extinguisher fire boxes. This month several gangway wheels were replaced as a preventive maintenance due to wear and tear.

#### IV. Marketing

The Maintenance Department continues to provide assistance to the Marketing Department on weddings, set-up for events, during events, installation of banners/flyers, or whatever the needs are to make a successful event. Additionally, staff assisted on the organization of all marketing storage containers. We are currently creating a storage area for marketing at the 1575 building.

# V. Construction Projects Phase One: COMPLETED

The Verizon Mono Palm project was started on April 26<sup>th</sup> and I've been meeting with Luke Beere, Superintendent from O.C.I.K Wireless telecom Specialist on a regular basis. I'm glad to report that the project is continuing to go well. O.C.I.K is on schedule. Phase One (construction) has been completed, the communication cabling/conduits have been run from the street side to the cell site, the cell site's foundation has been poured and the block brick walls for the communication room have been installed. All exterior stucco finish is completed. Antenna base has been set in place; all inspections from the City of Ventura have been passed.







#### **Phase Two: COMPLETED**

Phase Two (Communication) started last week. Phase Two consists of installation of the Mono Palm, all communication software, etc. Phase two is expected to be finished within the next two weeks. Phase Three (Landscaping repairs) will start after Phase Two is completed.





#### **Phase Three: COMPLETED:**

The Verizon Mono Palm project was completed this month. Inspections from all inspectors have passed; all landscaping has been done, and now considered 100% completed. Below are photos of the finished product.

#### **Public Safety Overview:**

The summer is now over and our efforts and planning resulted in a very successful experience for thousands of visitors. Staff met and exceeded the challenges during what I would estimate to be Ventura Harbors most visited summer to date. Both water and landside activities were up and our staff responded to the needs of the public. We will be tallying our stats to include in next months report.





We have already transitioned to preparing for the Fall/Winter months ahead. While we do not see the volume of visitors as we do in the summer, the emergencies are far more technical as the weather is often a significant contributing factor. Next month is the opening of lobster season. The addition of hundreds of unlit buoys will be returning to our local waters along with recreational hoop net fishermen and divers. This primarily nighttime activity can be inherently dangerous and has resulted in accidents in the past, including one fatality last year. We will closely monitor the season and work with allied agencies, as needed, to enhance safety.

#### **Boating Rescues:**

Our staff responded to numerous vessels in distress near the surf line this summer. This often occurs as people navigate too close to the shoreline. When they encounter mechanical problems they spend valuable time trying to make repairs before calling for assistance and dropping anchor. Even at times dropping anchor is ineffective due to the fact they cannot put out enough line for their anchors to properly dig in or wind and surf causes it to drag.









Sometimes vessels ignore our warnings to stay farther offshore. In one such case a sailboat was contacted multiple times over the course of a couple of days for being too close to the surf. On the third day when the winds picked up as forecasted the captain found himself unable to exit to safer waters and was washed aground. While there were no injuries the 32' sailboat became an immediate hazard to the safety of beach goers and the environment. The Port District and the City of Ventura collaborated to mitigate the hazard at one of our areas more popular beaches. The City financed the vessel

being pulled off the beach thanks to a significant discount from local business owner Paul Amaral of Channel Watch Marine Boat US.

#### **Landside Rescues:**

Included in most monthly reports are the 911 landside calls we also respond to. Due to our proximity and rapid response capability we are often first on scene to 911 calls in and immediately near the Harbor. This level of service is especially valuable to our community. Our primary efforts are to establish scene safety, provide a scene size up to incoming units, and provide lifesaving stabilization to victims. More often, just the positioning our truck with the emergency lights activated ensures no further accidents or injury occur to first responders. The past few months we also responded to and were first on scene to multiple traffic accidents in the Harbor area. Here is a snapshot of some.



#### **Beach Rescues:**

We did not see any significant beach rescues this summer for which we mostly attribute to the California State Parks Lifeguard contract and the additional Lifeguard Tower, which was placed at Surfers Knoll along with the mobile truck unit. There were a number of routine rescues and we will be collecting the stats from State Parks to include with next months stats.

This year we did have a number of stingray hits. This is the second year we have regularly seen this type of injury. We have perfected our response to include bringing a trashcan of hot water to the beach and victim. The hot water decreases the severe pain associated with the sting and in most cases the victim is significantly better within the next 30 minutes. In most of all of this year's responses, a full 911 response was not necessary due to the experience of our staff and Lifeguards with this issue.





#### **Moorpark & Thousand Oaks Beach Bus:**

Summer is over and I plan to follow up regularly with both of my contacts from each city. Both expressed they had never considered our Harbor before, but were open to the idea for the following summer. I will work with the Marketing Department to try to put together materials to enhance our chance of success.

#### **Port District & Ventura City Collaboration:**

The Port District received the matching funds from the City of Ventura for the June 7 deceased whale disposal. Due to a discount received by Paul Amaral of Channel Watch Marine, each party's share was approximately \$1200 dollars.

I am currently working with the City of Ventura Parks Department to dispose of the 32' sailing vessel that went aground on Marina Park this summer. Once the City gets title to the vessel, I will use the Surrendered and Abandoned Vessel Exchange (SAVE) grant money to dispose of the vessel.

#### **Harbor Patrol Injury & Illness Prevention Program:**

A number of years ago the Harbor Patrol implemented an in-house Injury & Illness Prevention Program to prevent on the job injuries and ensure our staff is best prepared for the arduous emergencies we are summoned to throughout the year. This program allows for staff to exercise within a very modest gym that was funded from the Harbor Patrol Budget and set up in the Port District Headquarters. The equipment is also available for use to all Port District Staff. Additional lockers were purchased last month so that office staff could store their workout clothing on site. The program has been a success and on the job injuries within the Harbor

Patrol have decreased significantly since 2012. This personal use equipment has started to show signs of age, intermittent failures, and will need to be replaced over the next year. I expect we will be able to purchase additional modest equipment while staying within our existing operational budget.

#### **Beach Trash and Deceased Marine Life:**

This summers large crowds trash exceeded our limited resources and receptacles. The Harbor Patrol along with Maintenance ended up picking up and emptying trashcans throughout the summer to continue our mission of providing a safe and enjoyable attraction.

Our beach and harbor encounters numerous deceased marine life throughout the year. The often large and decomposed carcasses provide a challenge to our staff. Unfortunately, there are no services to call to assist with this human health issue. We are left with limited ways we can mitigate these carcasses. Our three options are to bury it in place, relocate it to a more remote area of the beach, or tow it out to sea. Federal Law requires the carcass to be buried in a hole approximately 6-8' deep, relocating it requires some form of lifting/dragging, and towing it to sea sometimes results in it returning due to the winds and currents. This summer we had a deceased dolphin that washed ashore during the busy summer season and before a holiday weekend. The crowds began to gather and demanded officials do something. After weighing the options the safest and most efficient method to remove the hazard was to drag it behind a truck towards a remote area near the river mouth. State Parks Officials towed the dolphin roughly 200 yards down the beach to a location where other deceased marine life had been relocated. A beachgoer took video from his phone and sent it to the news. By the end of the day, on July 4, it had made nationwide news and our Harbor Patrol was mentioned in the news. Attempts to clarify that State Parks was the lead agency were essentially ignored because of the stories appeal to the public. Our staff closely monitored the story and at last check there were over 300k Facebook views to the story. About half the responses thought this was cruel and insensitive to the dolphin and the other half understood the actions taken. While I personally agree this was a reasonable and appropriate method to mitigate the human health hazard that this presented to the public, we are open to other ideas on how we might deal with this issue in the future.



SUBJECT: Marina Report

#### I. Repairs to Surfaces on the Fish Pier and DeLuca Squid loading area

The past several weeks has produced a temporary decline in squid offloading throughout California. This is not unexpected as we shift between summer and fall squid offloading seasons. We have taken this time to conduct repairs on two of our squid offloading areas.

The repairs were conducted on two days, Saturday, August 27 and Thursday, September 1, 2016. The time spent between the two dates were used for the base repair product to cure before application of the final top surface was applied. Both repaired areas are now ready for service.



The left picture is of the completed warranty surface repair directly underneath the Del Mar squid fish pump, which is located on the fish pier. This area was possibly compromised by a failure in the adhesion of the surface product. We will continue to evaluate the repair as time and squid offloading resumes.

Meeting Date: September 28, 2016

The right picture is of the completed surface repair of an area on the common driveway near the DeLuca fish pump that had begun showing signs of surface wear. It is my opinion that this area was not subject to a failure of a previously applied surface, but the result of normal wear and tear. This repair will help reduce further damage to the surface, as a result of heavy forklifts moving over what was previously a rough and uneven surface.



#### II. Ventura Harbor Village Marina Occupancy


In September, the Ventura Harbor Village slip occupancy fell to 90.0%. This was due to the temporary return to out of state home ports of some seine vessels during the current pause in squid offloading.

#### III. Damage and Repair to Slip D-26

The Dive Boat Spectre departed the slip on August 29 neglecting to disconnect the vessel's water hose from the dock. The dock base plate was ripped from the deck, severing the slip's water and electrical connections. The picture to the left reflects the damage that was done. District maintenance personnel repaired the damage and on September 7 the vessel owner was billed \$2,192.26 for the repair, which included parts and labor.

#### IV. Technology

Progress on the installation of the District's new ATT VOIP telephone system continues. The new equipment has been received and the installation started.

As part of being managed under a U.S. fishery management plan, they meet 10 national standards that ensure fish stocks are maintained and overfishing is eliminated. They work with the National Oceanic and Atmospheric Administration (NOAA), National Marine Fisheries Service (NMFS) and take an NMFS observer on each of their fishing trips.

### FISCAL IMPACT:

This new lease reflects current market rental rates for office space in the complex. The annual occupancy cost for this tenant is \$16,000. The minimum rent over the two year term is adjusted annually by 3% per year.

SUBJECT: Acceptance of \$169,660 Shellfish Grant

#### **RECOMMENDATION:**

That the Board of Port Commissioners authorize the General Manager to sign the *Cost Reimbursement Research Subaward Agreement* for \$169,660, which reflects the terms and conditions of the grant agreement for Year 2.

# **SUMMARY:**

The grant is for a two year period on a one-plus-one yearly basis and is contingent upon funding availability. Year 1 grant period is from September 1, 2015 to August 31, 2016. Year 2 grant period is from September 1, 2016 to August 31, 2017. The total two-year grant amount is approximately \$300,000 (\$265,000 to the District). Funding for both years has now been made available. The objective of the grant is to provide:

- A technically sound and thorough strategy to successfully obtain all required government entitlements necessary to establish twenty 100-acre aquaculture leases in the state waters of the Santa Barbara Channel.
- Successfully permitted applications for the leases, associated environmental review documents, and completed baseline sampling protocol and data necessary for a California Department of Public Health (CDPH) Shellfish Growing Area Certificate; and,
- A comprehensive outreach strategy aimed at soliciting the support and participation of various stakeholders by educating prospective commercial fishermen, investors/entrepreneurs, shellfish processors, and consumers about the benefits of locally sourced and sustainably raised mussels.

### **BACKGROUND:**

Increasing the supply of safe, sustainably produced domestic seafood is a priority for NOAA and the Department of Commerce. The Ventura Shellfish Enterprise (VSE) is a multi-stakeholder initiative that seeks to permit and manage a commercial shellfish culture is technically proven as a method for the production of high value seafood with limited environmental impacts. However, the permitting process in California for such production is uncertain and not adequately developed to attract participation. VSE seeks to address several regulatory and planning challenges that crate impediments to the expansion of a domestic marine shellfish culture industry in California.

Year 1 Task 1 - Strategic Permitting Analysis is underway but not complete. Task 2 – Environmental Reports and Permitting follows Task 1. Task 3 Education and Outreach includes website development, social media initiatives and educational workshops. The VSE website has been established and planning begins this fall for public workshops. Year two grant funding has been made available to the District in the amount of \$169,660.

Since Year 1 – Strategic Permitting Analysis is underway but not yet complete. The California Sea Grant as grant awardee (the District is sub-awardee) has agreed to request a routine extension allowing for a total of three years to complete Tasks 1-3. It is anticipated the extension will be granted by November 2016 which would provide the District through August 31, 2018 to complete Tasks 1-3.

### FISCAL IMPACT:

The grant requires a cost-share in the amount of \$192,610 for Year 1 and \$162,610 for Year 2 for a total of \$355,220. The cost-share is achieved through in-kind contributions of time as identified in the attached budget. Additional staff time and District legal counsel costs not reimbursable by the grant are necessary for grant and professional service agreement management.

VPD will directly pay approximately \$18,200 in unreimbursable consultant costs, plus \$8,500 in unreimbursable outside legal counsel expenses to explore alternative aquaculture leasing structures more fully discussed under separate report "Approval of Professional Services Agreement for Special Legal Services". If it is determined during the grant period there are additional budgetary impacts, staff will return to the Board.

An annual performance report must be submitted to the Program Office at least 90 days prior to the end of each budget period.

A final performance report that covers the remaining 90 days and summarizes activities conducted during the entire award must be submitted within 90 days following the end date of the project.

# 2) Data Sharing

Environmental data and information, collected and/or created under this grant/cooperative agreement will be made visible, accessible and independently understandable to users, free of charge or at minimal cost, in a timely manner (typically no later than two years after the data are collected or created) except where limited by law, regulation, policy or by security requirements.

- (1) The Data/Information Sharing Plan (and any subsequent revisions or updates) will be made publicly available at time of award and, thereafter, will be posted with the published data.
- (2) Environmental data and information produced under this award and which are made public must be accompanied by the following statement: These environmental data and related items of information have not been formally disseminated by NOAA and do not and should not be construed to represent any agency determination, view or policy.
- (3) NOAA may at its own discretion, use information from the Data/Information Sharing Plan to produce a formal metadata record and include that metadata in a catalogue to indicate the pending availability of new data.

#### SUMMARY:

The Ventura Port District has been awarded a two year, approximately \$300,000 Sea Grant fund (approximately \$265,000 to the District) to contract with qualified consultant(s) that will enable development of a permitting strategy, necessary permitting components, environmental reports and public outreach required for sustainably cultivated shellfish production to occur through Ventura Harbor.

Staff believes it is clearly in the District's best interest to ratify the amended agreement with *Plauché & Carr*, *LLP* to meet the objectives of the grant by providing outside legal counsel on the Task 1 - Strategic Permitting Analysis and Task 2 – Environmental Reports and Permitting as further detailed in the Sea Grant and Professional Services Agreements.

## **BACKGROUND:**

Plauché & Carr, LLP is a Seattle-based law firm with a practice focused on environmental, land use, and natural resource-based issues. Plauché & Carr, LLP has represented a number of non-profit, private, and governmental entities regarding environmental and regulatory matters ranging from regulatory compliance/permitting, to administrative litigation, to litigation in state and federal courts, to conservation land acquisition.

If the District approves the First Amendment to Professional Services Agreement with *Plauché & Carr, LLP* to continue to assist with the project, Robert Smith will continue to serve as lead counsel. Robert is an attorney with ten years' experience working in California on land use and environmental issues, on behalf of both private and public clients. During his previous employment at two Los Angeles-based firms, Robert advised and represented numerous clients regarding compliance with the California Environmental Quality Act ("CEQA") and National Environmental Policy Act ("NEPA") and represented several coastal cities and private clients before the California Coastal Commission ("CCC"), California Department of Fish and Wildlife ("CDFW"), Los Angeles County, and U.S. Army Corps of Engineers ("Corps").

### **SUMMARY:**

The Ventura Port District has been awarded a two year, approximately \$300,000 Sea Grant fund (approximately \$265,000 to the District) to contract with qualified consultant(s) that will enable development of a permitting strategy, necessary permitting components, environmental reports and public outreach required for sustainably cultivated shellfish production to occur through Ventura Harbor.

Staff believes it is clearly in the District's best interest to ratify the amended agreement with *Dudek* to meet the objectives of the grant by providing environmental consultant services on the Task 1 - Strategic Permitting Analysis and Task 2 - Environmental Reports and Permitting as further detailed in the Sea Grant and Professional Services Agreements.

# **BACKGROUND:**

Dudek will continue to work with the Ventura Port District and other VSE team members to identify and then clearly layout the most prudent and efficient permitting and review approach that also provides the greatest long-term benefits. The leases for mariculture activities and subsequent work proposed within navigable waters would be subject to a host of approvals from a variety of agencies, including federal (USFWS/NMFS, USACE), state (CA Coastal Commission, State Lands Commission, CDFW, RWQCB) and local agencies (Port of Ventura) for which the policy requirements must be met. By reviewing available materials and through pre-application meetings with the wildlife (NMFS, USFWS, CDFW) and other resource agencies such as USACE, the Coastal Commission and the California RWQCB, and by drawing from their combined experiences, *Dudek* will provide recommendations for successful environmental review and prepare the necessary State and Federal environmental documents.

Deliverables will include a Strategic Planning Document summarizing the path and timing of the necessary permits, data requirements, and reviews and necessary State and Federal environmental documents.

# **FISCAL IMPACTS:**

The grant is for a two year period on a one-plus-one basis and is contingent upon funding availability. Funding for both years has been made available. Year 1 funding is in the amount not to exceed \$65,350 for environmental consultant services. Year 2 funding is in the amount of \$137,200 for environmental consultant services. The combined Year 1 and Year 2 funding is \$202,550 for Dudek to provide the environmental consultant services. Of the \$202,550, \$184,320 (91%) will be reimbursable through the grant. \$18,230 (9%) will be paid with VPD funds.

The consultant will participate in meetings and teleconferences with various local, State and Federal resource managers and regulators as appropriate in a progressive order to further identify issues, explore opportunities, and decide upon a full plan that would meet regulatory approval.

The consultant will be available to the Ventura Port District and other VSE team members to ask and answer questions, offer guidance and direction, and discuss issues by phone or mail during the permitting/planning process.

### **FISCAL IMPACT:**

It has been necessary from time to time to amend the District's Conflict of Interest Code to conform its disclosure obligations to recent changes in the law, and to identify new positions within the District for which the job duties entail the making of decisions having a potential financial impact on the District, such that employees holding such positions are required to file disclosure statements under the District's Code. The District recently added two new staff positions; Facilities Manager and Business Operations Manager. Exhibit A to the proposed Resolution identifies all designated positions and the disclosure categories they file under.

Once the Board adopts Resolution No. 3317, approving the new Conflict of Interest and Disclosure Code, it will be transmitted to the County of Ventura, along with a form of Certification signed by the Secretary of the Board.

# RESOLUTION OF THE BOARD OF PORT COMMISSIONERS OF THE VENTURA PORT DISTRICT APPROVING ITS NEW 2016 CONFLICT OF INTEREST CODE

WHEREAS, the Political Reform Act, Government Code section 81000 et seq., requires local government agencies to adopt and promulgate Conflict of Interest Codes; and

WHEREAS, the Fair Political Practices Commission has adopted a regulation (2 Cal. Code Regs., § 18730) which contains the terms of a standard Conflict of Interest Code, which may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act after public notice and hearings; and

WHEREAS, the terms of California Code of Regulations, Title 2, Section 18730, and any amendment to it duly adopted by the Fair Political Practices Commission, are hereby incorporated by reference as the Conflict of Interest Code for the Ventura Port District, and along with the attached Exhibit A, which designates positions requiring disclosure and Exhibit B, which set forth disclosure categories for each designated position, constitute the Conflict of Interest Code of the Ventura Port District; and

WHEREAS, persons holding positions designated in Exhibit A shall file Form 700 Statements of Economic Interests with the Filing Officer specified for that position in Exhibit A; and

WHEREAS, in preparing the form 700, designated filers need only disclose those financial interests falling within the disclosure categories designated for that filer's position as stated in Exhibits A and B; and

WHEREAS, pursuant to said Act, the Ventura Port District ("District") adopted its initial conflict of interest code ("Code") which has since been updated and amended several times, with the latest action being the adoption of Board Resolution No. 3283 on September 9, 2015; and

WHEREAS, the Board has determined that it is in the best interest of the District to amend the Code in certain particulars outlining new positions in the District; and

WHEREAS, as a result of such amendment, the Board finds it is desirable and in the best interests of the District to rescind the existing Code and adopt the new Code in the manner set forth herein as Exhibit A; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Port Commissioners of the Ventura Port District hereby rescinds Resolution No. 3283 and all prior versions of the Code, which were previously passed, approved, and adopted by the Board, and adopts in its place Exhibit A, Exhibit B and Exhibit C of its Conflict of Interest and Disclosure Code of the Ventura Port District, to include additional positions within the District, which are shown on Exhibit A attached hereto.

BE IT FURTHER RESOLVED that those individuals holding newly designated positions, as set forth in Exhibit A, shall file Statements of Economic Interests with the Clerk of the District within 30 days of the adoption of this Resolution.

BE IT FURTHER RESOLVED that a secretarially certified copy of this Resolution, including the attached Exhibit A, B, and C, shall be forwarded to the Ventura Board of Supervisors as an amendment to the Conflict of Interest and Disclosure Code of the Ventura Port District.

# Category 2 – REAL PROPERTY

[SEE FORM 700 SCHEDULE B]

All interests in real property, including interests in real property held by business entities and trusts in which the public official holds a business position or has an investment or other financial interest.

# Category 3 – LAND DEVELOPMENT, CONSTRUCTION AND TRANSACTION

[SEE FORM 700 SCHEDULES A-1, A-2, C, D and E]

All investments, business positions and sources of income, gifts, loans and travel payments, from sources which engage in land development, construction, or real property acquisition or sale.

# Category 4 - PROCUREMENT

[SEE FORM 700 SCHEDULES A-1, A-2, C, D and E]

All investments, business positions and sources of income, gifts, loans and travel payments, from sources which provide services, supplies, materials, machinery or equipment which the designated position procures or assists in procuring on behalf of their agency or department.

# Category 5 – REGULATION AND PERMITTING

[SEE FORM 700 SCHEDULES A-1, A-2, C, D and E]

All investments, business positions and sources of income, gifts, loans and travel payments, from sources which are subject to the regulatory, permitting or licensing authority of, or have an application or license pending before, the designated position's agency or department.

# Category 6 – FUNDING

[SEE FORM 700 SCHEDULES A-1, A-2, C, D and E]

All investments, business positions and sources of income, gifts, loans and travel payments, from sources which receive grants or other funding from or through the designated position's agency or department.

### APPENDIX - DESIGNATING OFFICIALS WHO MANAGE PUBLIC INVESTMENTS

Pursuant to Government Code section 87200 et seq., certain city and county officials, as well as all "other officials who manage public investments," are required to disclose their economic interests in accordance with the Political Reform Act. This Appendix provides the relevant definitions for determining which public officials qualify as "other officials who manage public investments," designates the agency's positions which qualify as such, and states the Filing Officer for each designated position.

### **APPLICABLE DEFINITIONS**

As set forth in 2 California Code of Regulations section 18701, the following definitions apply for the purposes of Government Code section 87200:

- (1) "Other public officials who manage public investments" means:
- (A) Members of boards and commissions, including pension and retirement boards or commissions, or of committees thereof, who exercise responsibility for the management of public investments;
- (B) High-level officers and employees of public agencies who exercise primary responsibility for the management of public investments, such as chief or principal investment officers or chief financial managers. This category shall not include officers and employees who work under the supervision of the chief or principal investment officers or the chief financial managers; and
- (C) Individuals who, pursuant to a contract with a state or local government agency, perform the same or substantially all the same functions that would otherwise be performed by the public officials described in subdivision (1)(B) above.
- (2) "Public investments" means the investment of public moneys in real estate, securities, or other economic interests for the production of revenue or other financial return.
- (3) "Public moneys" means all moneys belonging to, received by, or held by, the state, or any city, county, town, district, or public agency therein, or by an officer thereof acting in his or her official capacity, and includes the proceeds of all bonds and other evidences of indebtedness, trust funds held by public pension and retirement systems, deferred compensation funds held for investment by public agencies, and public moneys held by a financial institution under a trust indenture to which a public agency is a party.
- (4) "Management of public investments" means the following non-ministerial functions: directing the investment of public moneys; formulating or approving investment policies; approving or establishing guidelines for asset allocations; or approving investment transactions.

### EXHIBIT C - ADDITIONAL CODE PROVISIONS

The following additions to the FPPC Standard Code are hereby incorporated into the Conflict of Interest and Disclosure Code of the Ventura Port District:

### DISQUALIFICATION

- 1. An investment, interest in real property, income or source of income of a designated employee shall not be a basis for disqualification under this Conflict of Interest Code where such interest will foreseeably be affected only by the decisions to fix an ad valorem property tax rate or uniform assessments for the District applicable to the public generally. (Cal. Code of Regs., Title 2, Section 18703)
- 2. After disqualification, a designated employee may make an appearance, submit information, or express views on the same basis as any other citizen on matters related solely to his personal interest, provided that it is done publicly and provided that the person clearly indicates he is acting in a private capacity.
- 3. Rule of Necessity: Item No. 1 (above) does not prevent a designated employee from making or participating in the making of a governmental decision to the extent that his participation is legally required for an action or decision to be made. The fact that a designated employee's vote is needed to break a tie does not make this participation legally required for the purposes of this section. The attorney for the District is empowered to advise any designated employee whether or not the "Rule of Necessity" is applicable in any particular instance.

### OPINIONS OF COUNSEL AND OF THE COMMISSION

- 1. Opinion Requests. Any designated employee who is unsure of any right or obligation arising under this Code may, with the prior approval of the General Manager, request a formal opinion or letter of advice from the FPPC or a written opinion from the attorney for the District.
- 2. Evidence of Good Faith. If an opinion is rendered by the attorney for the District stating the facts and the law upon which the opinion is based, compliance by the designated employee with the conclusions of such an opinion is evidence of good faith in any civil or criminal proceeding brought pursuant to the Political Reform Act of 1974 on this Code, but may not be conclusive as to whether the designated employee acted in good faith. The designated employee's good faith compliance with the opinion of the District's attorney shall also act as a complete defense to any disciplinary action that the District may bring under Section 91003.5 of said Act of this Code. A designated employee may also seek an opinion or advice letter from the FPPC pursuant to Government Code Section 83114, which shall act as a complete defense in any subsequent enforcement proceeding brought by the FPPC.

### STATUTE OF LIMITATIONS

1. No action based on a disqualification provision of this Code shall be brought pursuant to Government Code Section 91003(b) to restrain the execution of or to set aside official action of the District unless the complaint or petition is filed and served upon the District within 90 days following the official action.

### **DEFINITIONS**

1. The definitions contained in the Political Reform Act of 1974 (Government Code Section 81000 et. seq.) and regulations adopted pursuant thereto are incorporated into this Conflict of Interest Code. Conflict of Interest disclosure reports shall be made on Fair Political Practices Commission Form 700, or any successor forms thereto.

### **RECOMMENDATION:**

That the Board of Port Commissioners authorize funding in the amount of \$8,500 to retain outside legal services provided by *Plauché & Carr, LLP* to analyze and report on leasing alternatives related to the Shellfish Grant.

### SUMMARY:

The Ventura Port District, in collaboration with the Ventura Shellfish Enterprise (VSE), was awarded a two year, approximately \$300,000 Sea Grant (\$265,000 funding directly to the District) to contract with qualified consultant(s) that will enable development of a permitting strategy and all necessary permitting components required for sustainably cultivated shellfish production to be landed at Ventura Harbor.

There has been significant progress made in Task 1 of the Shellfish Grant, which is the research and development of a permitting strategy as outlined above. However, it has become evident that the scope and funding allocated from the Sea Grant for Task 1 legal services is insufficient. Given that the State California Department of Fish and Wildlife ("CDFW") has issued very few leases for offshore aquaculture over the past two decades (primarily renewals), there is a lack of clarity as to what leasing structures may be available to this District, or other government entities, and cooperatives such as the VSE.

### **BACKGROUND:**

Plauché & Carr, LLP is a Seattle-based law firm with a practice focused on environmental, land use, and natural resource-based issues. Plauché & Carr, LLP has represented a number of non-profit, private, and governmental entities regarding environmental and regulatory matters ranging from regulatory compliance/permitting, to administrative litigation, to litigation in state and federal courts, to conservation land acquisition. On October 14, 2015 the District selected Plauché & Carr, LLP and Robert Smith as lead counsel to provide the Task 1 legal services for the Shellfish Grant.

For this additional task, Robert Smith will also serve as lead counsel. Mr. Smith is an attorney with ten years' experience working in California on land use and environmental issues, on behalf of both private and public clients. During his previous employment at two Los Angeles-based firms, Robert advised and represented numerous clients regarding compliance with the California Environmental Quality Act ("CEQA") and National Environmental Policy Act ("NEPA") and represented several coastal cities and private clients before the California Coastal Commission ("CCC"), California Department of Fish and Wildlife ("CDFW"), Los Angeles County, and U.S. Army Corps of Engineers ("Corps").

The Shellfish Grant contemplated the Ventura Port District, as a member of VSE would hold all entitlements for a group of offshore aquaculture leases that will in turn be subleased to individual producer-fishermen for shellfish farming. However State regulations are silent on subleasing, instead providing guidance only for assignments of lease. CDFW is reviewing these leasing requirements and evaluating options while seeking input from potential lessees. Mr. Smith will provide a report with an analysis of likely alternatives that CDFW may permit, and

important considerations of each alternative for the District. Mr. Smith will present the findings of his report to the Commission.

As a follow up task, Mr. Smith can assist the District in preparing draft lease documents and negotiating with CDFW. However, staff believes it is premature to authorize this work which is preliminarily estimated at \$10,000.

### FISCAL IMPACT:

The additional legal services for *Plauché & Carr*, *LLP* are not to exceed \$8,500. The District has funds available for the professional services.

### **RECOMMENDATION:**

That the Board of Port Commissioners receive a presentation from Safe Harbor Marinas regarding the proposed dock replacement plan as required by the Amendment No. 3 to 2003 VIM Master Lease approved on April 13, 2016.

### **SUMMARY:**

On April 13, 2016 the Board of Port Commissioners approved the Consent to Assignment of Lease and Leasehold Deed of Trust for Ventura Isle Marina from CLP Ventura Marina, LLC, ("CLP") CLP to SHM Ventura Isle, LLC ("SHM Ventura Isle"); and Amendment No. 3 to 2003 VIM Master Lease.

### **BACKGROUND:**

A major provision of the Amendment No. 3 to Ground Lease include replacement of certain VIM dock(s) with the following schedule: SHM Ventura Isle is required to retain an engineer within 30 days of the executed Amendment No. 3 to develop a plan for the replacement and possible reconfiguration of docks G, H and I (Phase I Dock Work). That plan is to be submitted to the District within three (3) months. Once approved by the District, SHM Ventura Isle will have three (3) years to complete the Phase I Dock Work. Within two (2) years of the executed Amendment No. 3, SHM Ventura Isle is required to retain an engineer to develop a plan for the replacement and possible reconfiguration of docks L and M (Phase II Dock Plan). That plan will be submitted to the District within three (3) months. Once approved by the District, SHM Ventura Isle will have three (3) years to complete the Phase II Dock Work.

SHM submitted a plan for both Phase I and Phase II Dock Replacement of G, H, I, L, and M and presented it to staff. SHM then resubmitted plans with minor modifications resulting from staff comments. SHM is prepared to present these plans to the Board as in informational item only to receive Commission and public comment.

### FISCAL IMPACTS:


The District will receive a one-time plan review fee of \$2,500 from SHM. Additionally the District will retain environmental consultant services ranging from approximately \$30,000 to \$35,000. However, SHM will pay for the environmental consultant services.


### **NEXT STEPS:**


The District will retain and direct environmental consultant services to begin the California Environmental Quality Act (CEQA) document preparation which is a four to five month process. Staff will return to the Commission in the 1<sup>st</sup> quarter of 2017 with formal recommendations regarding certification of the environmental documentation and approval of the proposed project.

Attachment 1-VIM Dock Replacement Plan








